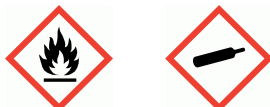

Protective actions during firefighting	Avoid breathing fire gases or vapors. Evacuate area. If a leak or spill has not ignited, use water spray to disperse vapors and protect men stopping the leak. Control run-off water by containing and keeping it out of sewers and watercourses.
