Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapors. Evacuate area. Methods and material for containment and cleaning up

Methods for cleaning up Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Avoid contact with eyes. Avoid inhalation of vapors and spray/mists.
